Revocation

1. I revoke all earlier Wills.

Appointment of Executor

2. I appoint as my Executor my husband DAVID SOLOMON A/L NEELA THOMAS JOSHUA, Malaysia NRIC No. 630613-08-5825, of No.1, JALAN BK 6B/1B, BANDAR KINRARA, 47180 PUCHONG, SELANGOR, MALAYSIA. If he is unwilling or unable to act for whatsoever reason, then I appoint my daughter AMANDA SANGEETHA THOMAS, Malaysia NRIC No. 910221-14-5450, of No.1, JALAN BK 6B/1B, BANDAR KINRARA, 47180 PUCHONG, SELANGOR, MALAYSIA, as my Executor. If both my husband DAVID SOLOMON A/L NEELA THOMAS JOSHUA and my daughter AMANDA SANGEETHA THOMAS are unwilling or unable to act for whatsoever reason, then I appoint my brother-in-law MANUVAL THOMAS, Malaysia NRIC No. 650309-08-6063, as my Executor.
3. In this Will, unless it is specifically stated to the contrary, my Executor shall also act as my Trustee.
